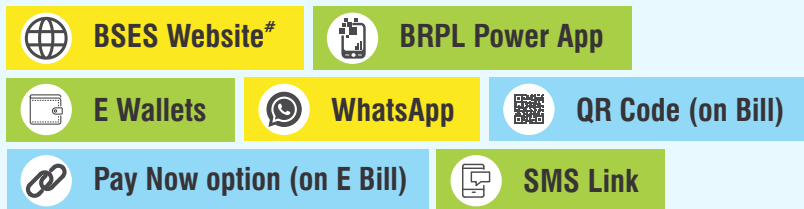
Moreover, under the DERC (Supply Code and Performance Standards) Regulations, 2017, it is mandatory for all consumers to have an ELCB installed at their premises, irrespective of the sanctioned load.

According to DERC's recent tariff order, it is mandatory for all consumers (except Domestic, Agriculture & Mushroom Cultivation) to pay their monthly electricity bills exceeding Rs 20,000/- through digital modes w.e.f October 1, 2021*

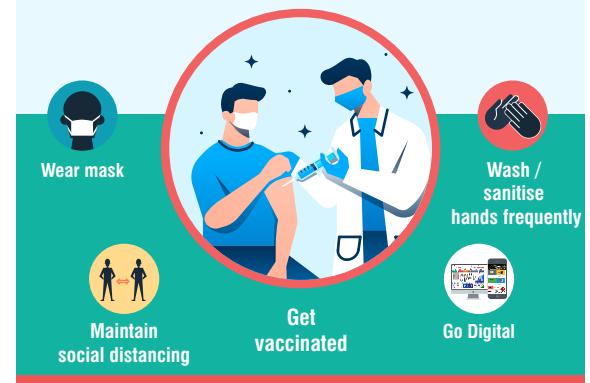


#Payments can be made through Net Banking (IMPS / NEFT/RTGS), BBPS, UPI QR Code and Credit / Debit Cards
